This form is to assist you in filing a Petition pursuant to Ala. Code § 13A-11-61.3 of the Alabama Firearms and Weapons Law. This section provides that “a person adversely affected by any order, ordinance, or rule promulgated in violation of this section may file a petition with the Attorney General requesting that he or she bring an action in Circuit court for declarative and injunctive relief. The Petition must be signed under oath and under penalty of perjury and must include specific details regarding the alleged violations.”

Instructions:

1. The law does not require you to use this complaint form, nor does the law prohibit anonymous complaints. However, if you submit a complaint by telephone or e-mail or if you use a different complaint form or if you use this form but refuse to provide your contact information and signature or if you make some other form of anonymous complaint, your complaint may or may not be investigated, at the discretion of the investigative agency.

3. Please complete all sections of this form that you can, using additional pages if necessary. If you do not know the answer to a question, write “unknown.” DO NOT guess or make up information.
